## 1 PURPOSE

The purpose of this Pricing Schedule is to provide information and guidance to customers relating to the current fees and charges for Solo Waters services for the 2020/21 financial year. All fees and charges are GST Free unless stated otherwise.

### 1.1 Scope

- Property, Building and Connection Fees
- Fixed Service and Volumetric Usage Charges
- Residential Miscellaneous Charges

### 1.2 Objective

## 2 DEVELOPMENT, PROPERTY, BUILDING AND CONNECTION FEES

The following table identifies fees applicable to undertaking any property, building and development works and/or for connecting new building works to Solo Water Infrastructure.

### 3 FIXED SERVICE AVAILABILITY AND VOLUMETRIC USAGE CHARGES

Charges for drinking water, recycled water and sewerage services are broken up into a fixed service availability charge and a variable water usage charge.

The fixed service availability charges relate to the cost of provision of infrastructure to the lot and are payable from the date the service is provided to the lot, whether you have built a house or not.

A summary of the fixed service availability charges are provided in the following Table.

In addition to the fixed charges the variable water usage charges apply once you move into your house and start using water. We do not charge a variable charge for the pressure sewerage service.
