STANDARD FEES & CHARGES

STANDARD FEES:

Standard fees are payable for all change of ownerships and to undertake the special meter read, as per the current version of the Solo Water Pricing Schedule that is available to view and download at www.solowater.com.au/downloads.

We will contact the applicant and provide an invoice for payment when this form is processed.

Payment methods include Credit Card or Direct Deposit.

PLEASE NOTE:

Only complete application forms will be accepted. Incomplete applications will need to be resubmitted.

Applications must be submitted via email to info@solowater.com.au.

For all change of ownerships other than vacant land, the Buyer must provide a cross connection test certificate from a licenced plumber to certify there are no cross connections with the drinking water and reycled water supplies at the premise. The test certificate must be dated within 14 days of settlement.

For all change of ownerships other than vacant land, the Buyer must arrange for Solo Water to undertake a special meter read so the final account balance can be settled. The special meter read must be undertaken within 7 days of settlement.

Failure to provide the details of the new owner will result in the previous owner being billed until the new owner is set up as a Solo Water customer.

Failure to settle the outstanding account balance at settlement will result in the new owner being liable for all outstanding accounts of the previous owner.

If the future owner or occupier has any special or life critical water needs please advise Solo Water in writing prior to the house being occupied.
